wish to apply to participate in the Victorian Gambling and Casino Control Commission-approved Self-Exclusion Program (SEP 1) administered by the Australiar Hotels Association (Victoria).

- a. I understand and acknowledge that signing this application for Self-Exclusion is my own decision and that it is my responsibility to not attend the gaming areas of my nominated venues and to not play gaming machines at those venues.
- b. I acknowledge that I understand the Australian Hotels Association (Victoria) Self-Exclusion Program and the effect of me signing this application for Self-Exclusion.
- 3. I request the Australian Hotels Association (Victoria) and Community Clubs Victoria (the "Industry Bodies"), the licensee of the venue/s or their

representatives take reasonable steps necessary to enforce my decision to Self-Exclude from the nominated venue/s and seek the support of the Industry Bodies and the venue licensees and their representatives to enforce my decision.

4. I understand that upon entering this Self-Exclusion Program I will remain Self-Excluded from the gaming areas of the nominated venues for a minimum of six (6) months up to the period I nominate (a maximum of two (2) years) and that I will also be ineligible to participate in any gaming-related loyalty program offered by the nominated venue/s for the period.

My undertakings during my Self-Exclusion period

- 5. I undertake to:
 - a) Not attempt to cancel or revoke any aspect of this Program other than as provided for in clause 8 of this application form;
 - b) Not enter the gaming area and to not play the gaming machines at the nominated venues;
 - c) Immediately stop using gaming machines and/or leave the gaming area of the nominated venue/s at the request of the Industry Bodies, the venue licensee, or their representatives;
 - d) Not seek to become a member of any gaming-related loyalty program made available by the nominated venue/s.

My authorisations during my Self-Exclusion period

- 6. I authorise and request the Industry Bodies, the licensee of the venue/s or their representatives during my period of Self-Exclusion:
 - a) To ask me to immediately stop using gaming machines and/or to immediately leave the gaming area at the nominated venue/s;
 - b) If I refuse, to take necessary action, including reasonable force, to ensure compliance with such directions;
 - c) To take such other action as reasonably necessary to prevent me from entering the gaming area and from using gaming machines and to remove me from the gaming area at the nominated venue/s and including removal from or suspension of any nominated venues loyalty program; and

- d) To take, retain and to circulate to the nominated venue/s my photograph and personal details for the purposes of the Self-Exclusion Program having regard to the Privacy Act.
- 7. I authorise the Industry Bodies, the licensee/s and the representatives of the nominated venues, within the period of my Self-Exclusion, to:
 - a) Retain, use, and display my name and photograph at the nominated venue/s in an area accessible to venue staff only to allow venue staff to identify me as a Self-Excluded person and for no other purpose.
 - b) Notify any relevant persons to take necessary action to prevent my access to, or my participation in, gaming-related loyalty schemes or gaming-related venue promotions.
 - c) Use appropriate technology, including facial recognition if available, to assist in giving effect to my participation in the Self-Exclusion program.

Action by me to revoke or terminate my Self-Exclusion

- 8. I may revoke my Self-Exclusion, but only:
 - a) After the expiry of a minimum of six (6) months;
 - b) By producing written evidence that I have received counselling from an appropriately qualified Counsellor in respect of my proposed revocation of my Self-Exclusion; and
 - c) After signing and lodging with the Industry Bodies a request for the revocation of my participation in the Self-Exclusion Program including the deletion of my photograph.
